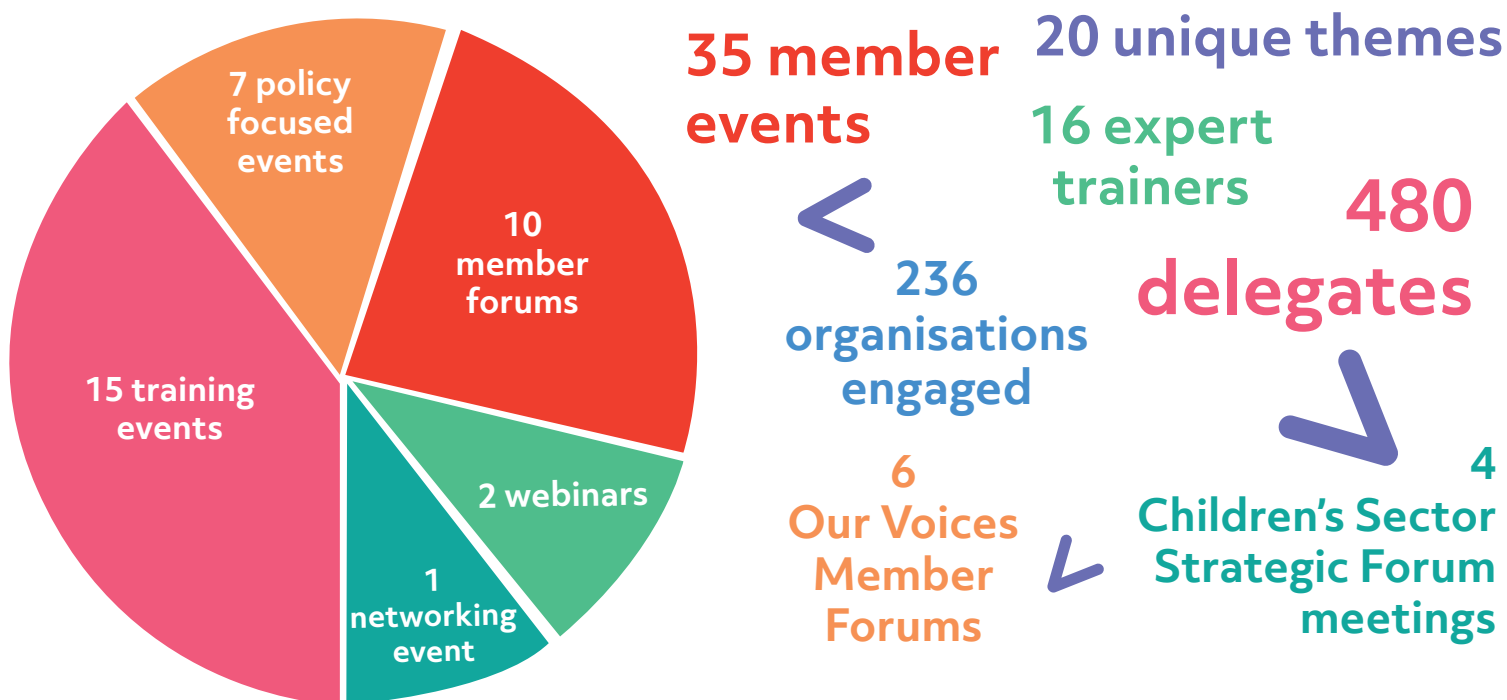


# Children in Scotland

## Free member events: 2017-18 review

Children in Scotland offers a diverse range of free members' learning events, shaped by members needs, and offering members opportunities to learn, network and contribute their views on a range of policy and practice related issues. We have gathered valuable feedback from members who have attended our events. This report provides an overview of anecdotal and statistical information about free member events between April 2017 and March 2018.



## Learning events

As part of our efforts to strengthen the children's sector workforce we organise a comprehensive programme of training workshops, seminars, conferences and other events. This programme includes a range of free learning opportunities for Children in Scotland members.

### Member feedback

- 94% of members rated the knowledge of their trainer as good or excellent
- 92% of delegates rated trainer delivery as good or excellent
- 88% of delegates rated course content as good or excellent

# Members' Forums

Our Members' Forums have been developed to meet the needs of the children's workforce while also providing the opportunity to bring members together with the ambition of influencing policy and practice.

## Children's Sector Strategic and Policy Forum

This group meets at least four times per year and takes a pro-active and evidence-based approach to improving children's lives at a national level. Membership is made up of Children in Scotland Members who hold senior positions within the children's sector and we are pleased to have secured the attendance of the Permanent Secretary at our 2018 meetings. There are also up to five places per meeting for individuals in membership with specific expertise relevant to the topic under discussion. At the Forum, Members pool their knowledge and expertise to come together and help identify children sector-wide solutions.

## Voices Forum

Voices brings together the diverse knowledge, skills and experience of our members to seek solutions for the most pressing issues affecting children in Scotland today. Combined with participation from children and young people, and outputs from our Children's Sector Strategic and Policy Forum, it is a powerful collection of voices calling on decision-makers to improve children's lives.

The Forum holds four events per year, complemented by opportunities for Members to feed in their views and ideas remotely.

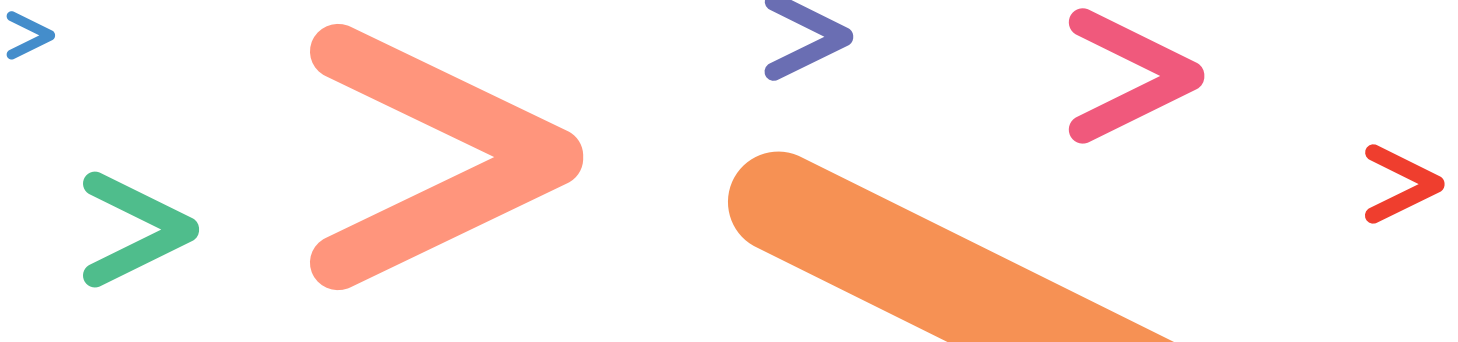
